I have no physical or mental limitations that are an obstacle to the safe performance of skydiving and can lead to the risk of injury, damage or death to me and my dependents during the preparation and at the time of the jump, that is I do not suffer from:

- cardiovascular diseases;

- loss of consciousness, convulsions;
- hearing damage;
- diseases and disorders of the nervous system, psychiatric diseases (epilepsy, schizophrenia, etc.);

- kidney disease.

FORBIDDEN

1. To change the jump task without the instructor's permission.
2. Without the permission of the instructor to replace any part of the parachute system (AAD, harness, main and reserve parachute), pass your parachute for jumping to someone else, as well as perform jumps on someone else's parachute system.
3. To perform jumps without an AAD on the parachute system.
4. To be in the packing area or on the line of initial inspection for the persons who do not carry out preparations for jumping.
5. To be in the runway or approach aircraft without the permission of the air traffic controller or jump supervisor.
6. To deploy the main parachute at an altitude below 700 m.
7. To make landings at the place of parachute packing, on the runway and at the place of aircraft loading, as well as to be above these areas at an altitude of less than 100 m.
8. To make turns of more than 100° at a height of less than 100 m.
9. To smoke in the area of parachute packing or on the starting line.
10. To drink alcohol at the aerodrome.
11. I am read to bear responsibility in case of intentional or unintentional violation of the rules of staying at the aerodrome or performance of parachute jumps in accordance with the established procedure.
